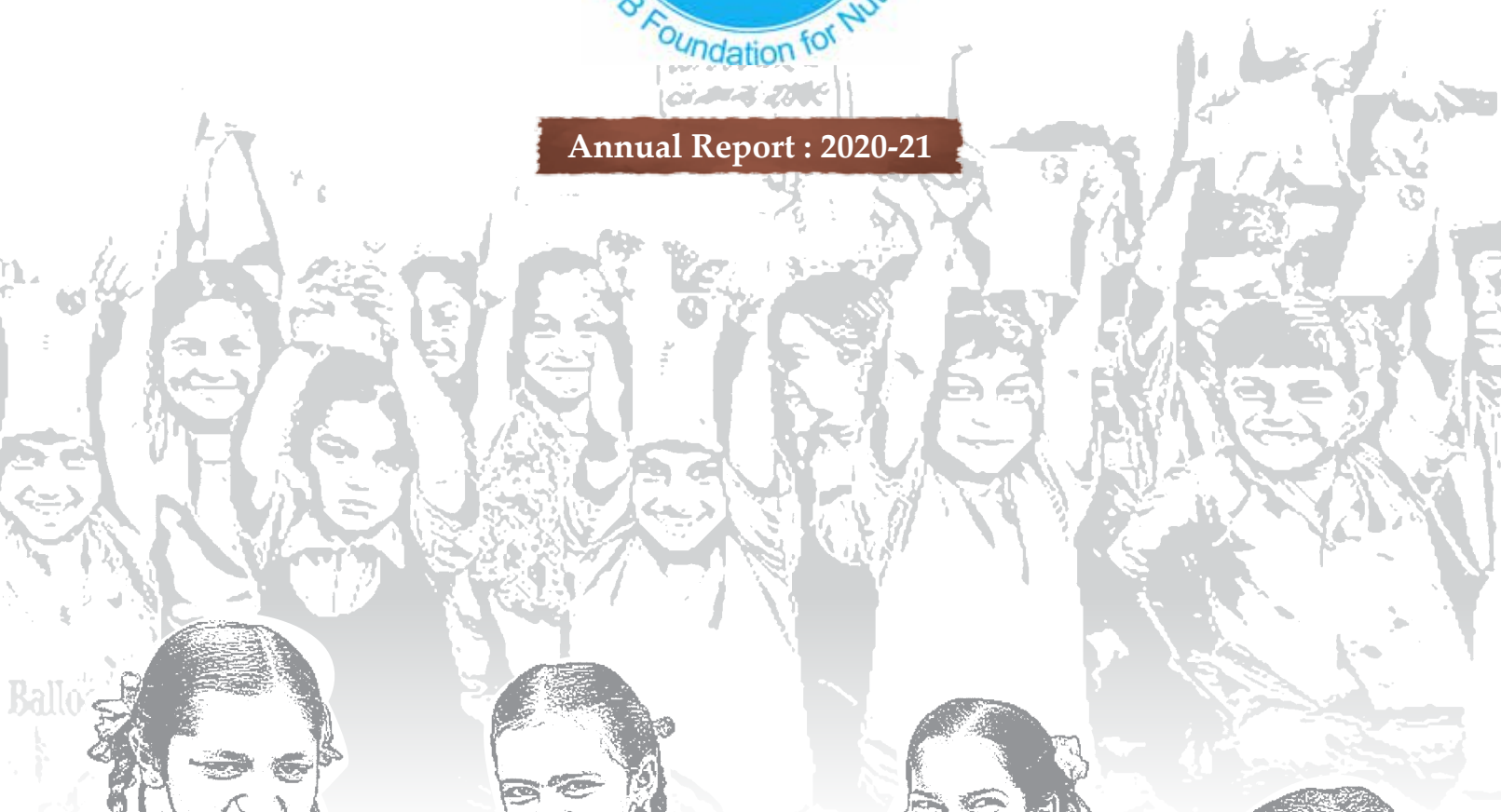

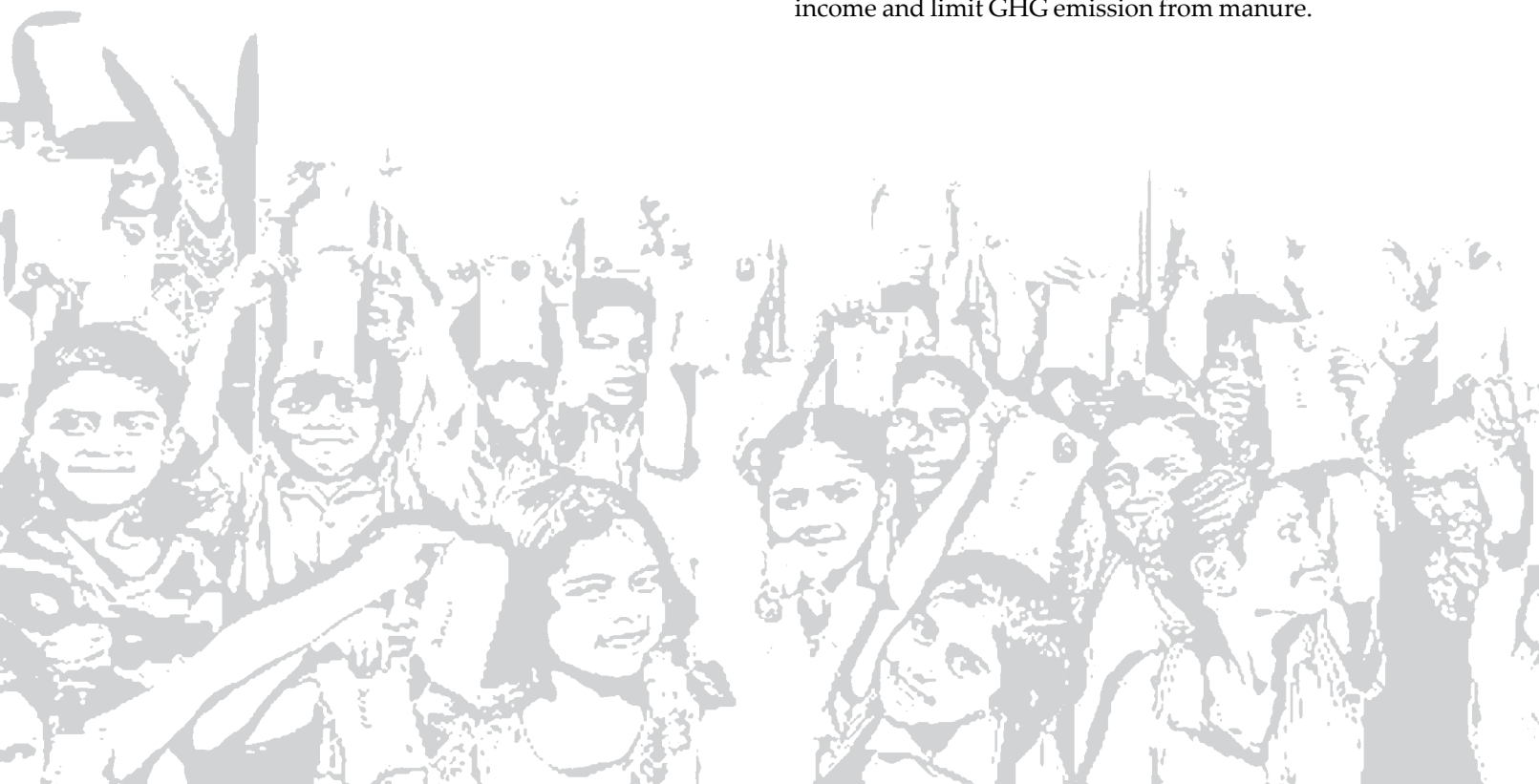
The year 2020-21 was a unique year, perhaps an aberration, in one's lifetime. Not even a single dimension of society has been spared of effects of COVID-19, a word which has left an indelible mark on almost every soul across the globe. The year was pretty challenging for NDDDB Foundation for Nutrition owing to outbreak of COVID-19 across the globe and subsequent closure of schools as part of mitigation measures to stall the spread of COVID-19.

Though, Children were not the direct face of COVID-19 pandemic, they risk being the real victims at large. The socio-economic impact of COVID-19 had a profound effect on well-being and future growth of our children. The closure of schools as part of mitigation measures adopted to stall spread of COVID-19, limited the access to basic nutrition for children, especially those belonging to the vulnerable sections of society, who were dependent on the school meal scheme for their daily intake of nutrition. The situation

was unavoidable owing to larger safety of masses. The COVID-19 crisis threatened to dilute the progress made by Government to address the problem of malnutrition in the country.

Hardships test the true mettle of any organisation. Overcoming the situational crisis of COVID-19, NFN reaffirmed its support and adapted itself to remain committed to its mission of addressing malnutrition amongst the children of our country. NFN reached out to children and distributed Giftmilk on Take Home basis. Fortified sterilised milk was distributed to students on a fortnightly or monthly basis for consumption at home. NFN for the first time expanded its Giftmilk Programme to cover North-Eastern states of India.

With an objective to promote ecological and sustainable models of agriculture and allied activities to enhance nutritional security of households, NFN, during 2020-21, introduced Go-Green Manure Management Programme. The programme is expected to enhance household income and limit GHG emission from manure.





The achievements of NFN during 2020-21 would not have seen light of the day, but for the support of donor partners, suppliers- our own dairy cooperatives and the school fraternity. I express deep gratitude to our suppliers who despite COVID-19 restrictions provided milk to schools. I also appreciate the efforts of school fraternity who showed willingness to implement the programme.

I thank all the stakeholders who supported NFN in its pursuit to address malnutrition. NFN will remain resolute at utilising every opportunity to reach out to the children more so, during these testing times and contribute towards building a stronger, healthier & prosperous nation.

NDDB Foundation for Nutrition's core objective

To provide nutritional support to Government school children through supply of nutritious products by a network of milk producer organisations (dairy cooperatives and producer companies) to help reduce malnutrition.



The year in retrospect

Background

The Financial Year 2020-21 witnessed some unprecedented challenges owing to outbreak of COVID-19 across the globe. To restrict the spread of COVID-19 among masses, the containment measures adopted by States viz, quarantine requirements, social distancing norms, lockdowns, border closing, etc., disrupted supply and distribution networks making the availability and accessibility of food uncertain across the country. However, the most alarming of it all was the closure of schools across the country.

The closure of schools not only disrupted education of children but also adversely affected access to basic nutrition for children especially those belonging to the vulnerable sections of society who were dependant on the mid-day meals scheme (MDMS) of schools for their daily

intake of nutrition. According to a report by the United Nations, the school nutrition programme approximately covers about 370 million children globally, with the largest beneficiaries being India (about 100 million). The MDMS has catered to about 9.17 crore children in 11.35 lakh schools across the country in 2018-19 and its dependency has only grown thereafter. The COVID-19 crisis threatens to reverse the progress made by various Government Programmes to address the problem of malnutrition in the country. Various States in the country came up with different measures to address the problem of discontinuation of MDMS in the schools. While some states distributed dry ration on take home basis along with allowance for cooking cost, others remitted monthly allowance in Parents' Bank account towards monthly ration of children.



Giftmilk Programme

Despite prevailing instability and uncertainty during FY 2020-21, NFN reaffirmed its support and took key measures to remain committed to its mission of addressing malnutrition among the children of our country.

The closure of schools due to COVID-19 pandemic as a part of containment measures, resulted in temporary break in implementation of Giftmilk Programme in its existing schools during the first two quarters of 2020-21. However, NFN has been resolute at utilising every opportunity to reach out to the children, more so in these testing times for the children dependant on school meals for their nutrition needs.

NFN took the initiative to distribute Giftmilk on Take Home basis for its programme schools in Delhi, Gujarat and Tamil Nadu under the CSR assistance of ITPO, IDMC and IIL after seeking consent of donor agencies. NFN distributed around 3,50,000 units on Take Home basis in the above states during 2020-21.



Reaching out to students in North-Eastern part of India:

NFN collaborated with National Highways & Infrastructure Development Corporation Limited, Delhi (NHIDCL) in January 2021 through an agreement for implementation of Giftmilk Programme in the North-Eastern states of India. Around 11,000 students studying in 21 Government schools were covered under Giftmilk Programme in the states of Manipur, Nagaland, Sikkim and Tripura. About 3.4 lakh units were distributed among the students during a span of around 3 months. 200 ml fortified sterilised flavoured milk was provided on all working days to the identified government school students in the form of both - daily distribution for immediate consumption at school for those who attended the classes and on Take Home basis for those who did not attend classes due to COVID-19 restrictions.

NFN joined forces with Public Sector Enterprises like Electronics Corporation of India Limited (ECIL), National Fertilisers Limited(NFL), The Shipping Corporation of India (SCI) and Mazagaon Dock Shipbuilders Limited (MAZDOCK) to implement Giftmilk Programme for 1,200 children in Bhupapally, Telangana; 500 children of Guna, Madhya Pradesh; 1,500 and 5,000 children of Gadchiroli, Maharashtra respectively. The programmes are scheduled to be implemented during 2021-22.



Go-Green Programme

With an objective to promote ecological and sustainable models of agriculture and allied activities to enhance nutritional security of households, NFN, during 2020-21, introduced Go-Green Programme.

Manure Management Project (under Go-Green component of NFN) aims at enhancing nutritional quotient of the soil by manure management and at the same time attain environmental benefits by mitigating contribution of dairying in global climate change through limiting the GHG emissions from manure.

Further, utilisation of bio-gas for cooking needs of household provides a cleaner alternative domestic fuel leading to health benefits and reduce drudgery of womenfolk. Further, direct use of slurry produced as agriculture input, can reduce the application of chemical fertilisers resulting into savings for farmer and improvement of health of the soil leading to nutrient availability in food. Sale of slurry & slurry based products adds to

household income for farmers. All in all the Manure Management project helps in making dairying sustainable for farmers by value addition to the by-product of dairy farm i.e. cattle manure. Major benefits include-



Cleaner alternative domestic fuel – health benefits



Reduce drudgery of womenfolk



Saving due to reduced application of chemical fertilizers



Improvement of soil health-nutrient availability in food



Income generation- sale of slurry and slurry based products

An agreement was signed with Cuttack Milk Union in January 2021 for Manure Management Project (Go-Green component of NFN) under CSR funding of IIL. 100 women farmers will be covered under the project wherein bio-gas plants will be installed at women farmers' household in a cluster mode. Procurement of slurry for processing and production of slurry based products (bio-fertilisers) will be taken up which will be marketed and sold under SuDhan brand of NDDDB. 64 out of total 100 bio-gas plants were installed at farmers' doorstep in the operational area of Cuttack Milk Union during 2020-21.

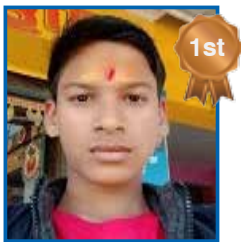


Other Initiatives

Awareness Programmes

Social media platforms were put to use for awareness generation and impart regular guidance regarding healthy living during the COVID-19 crisis. A webinar was organised on the topic 'Milk as a medium to improve immune system during COVID-19', wherein subject experts discussed milk's contribution in immunity building and related policy facilitations to improve its access to the masses. Another webinar was organised to spread awareness on 'Importance of healthy eating for School Students'. The key speaker was Dr. Seema Puri, Associate Professor, Institute of Home Economics, University of Delhi. Students from Giftmilk schools across the country participated in the webinar.

Moreover, in lieu of schools being closed due to the COVID-19 crisis, a National Online Painting Competition was held by NFN and NDDB to celebrate World Milk Day 2020 (June 1, 2020). The competition was held for children belonging to the age group of 10 to 15 years with the theme "Milk the key to physical and mental strength". Though being a first of its kind initiative by NFN and NDDB, an overwhelming response was received from across the country. The top three winning entries were awarded with a cash prize of ₹10,000, ₹7,000 and ₹5,000 each along with a certificate of merit.

National Poshan Maah

NFN celebrated National Poshan Maah in September 2020 to contribute towards national awareness drive. Nutrition Awareness Week was organised from 21st to 26th September 2020. As a part of Nutrition Awareness week, an awareness campaign was organised through social media to make people aware about nutrition and its importance in one's life. In association with Giftmilk supply partners and Dairy federations, a display vehicle with public address system was used for disseminating awareness messages related to importance of nutrition in selected areas; banners with information and infographics were displayed in public places such as milk parlours.

Further, to disseminate the information pertaining to experience of school milk programmes in India and at the same time promote it for greater coverage across the country, NFN facilitated participation of NDDB in a webinar organized by IDF on World School Milk Day, 30th September 2020. A presentation was made on – 'School Milk Programmes: Investing in the future of India' as a part of the webinar. Acknowledging importance of nutrition in the first 1,000 days for the building block of a healthy child, NFN facilitated NDDB in organizing an e-campaign on breastfeeding during the 1st week of August 2020. The e-campaign aimed at promoting and spreading awareness about significance of breastfeeding for overall development of a child.

Support to 'Delhi Against Malnutrition' Campaign

Steadfast at contributing even at the times of adversity, NFN associated with 'Delhi Against Malnutrition (DAM)' campaign to support children in the hour of crisis owing to COVID-19 pandemic. As a part of the association, Mother Dairy Fruit & Vegetable Private Limited (MDFVPL) acted as a supply partner for distribution of milk

packets during lockdown period to vulnerable children to address malnutrition. The campaign successfully culminated on 9th May 2020. About 1,500 units were distributed on daily basis. A total of 18,000 packets were delivered under the campaign, of which, about 7,000 packets were distributed in collaboration with MDFVPL.

Contribution of Stakeholders

NFN acknowledges the contribution of all the stakeholders- the donor agencies, milk supply partners- the dairy cooperatives, school principals & teachers and most importantly the students & parents. Distribution of milk on Take Home basis during the testing times of COVID-19, required unconditional support of our supply partners and members of school fraternity. The dairy cooperatives helped to deliver milk as per requirement, to the remotest locations in the programme schools. Credit goes to our programme school fraternity who agreed to implement the Giftmilk Programme on Take Home basis despite schools being closed.



Initiatives

Achievement of Giftmilk in 2020-21

During the year, NFN received donations of about ₹318 lakh. It spent around ₹134 lakh. NFN covered around 17,000 students studying in 39 Government schools in 7 States namely, Delhi, Gujarat, Tamil Nadu, Manipur, Nagaland, Sikkim and Tripura in association with its donor partners, namely India Trade Promotion Organisation, National Highways & Infrastructure Development Corporation Limited and NDDDB subsidiaries MDFVPL, IDMC and IIL. Out of these 50% students were girls and 40% were from SC/ST category. NFN served around 6.4 lakh Child Milk Days (CMD) throughout the year. CMD means one child getting a glass of milk for a day.

Road ahead

NFN envisages to cover new schools in Gujarat, Maharashtra, Jharkhand & Telangana and expand the Giftmilk Programme to new states like Bihar, Madhya Pradesh & Odisha. NFN also plans to operationalise Shishu-Sanjeevani Programme for Anganwadi children and reach out to remote locations where there is limited awareness about importance of proper nutrition. In its mission to address nutritional deficiency in the country, NFN will strive to reach out to other segments like pregnant women, lactating women, adolescent girls et al.

NFN also plans to introduce new programmes of Manure Management under Go-Green component of NFN and contribute towards additional income at household level in rural areas. The programme will also encourage women participation at village level.

With a renewed spirit, NFN will pursue its commitment to provide nutritional support to the children across the country. The hope for a better future for all our beneficiaries, especially children, gives us the energy to serve more and serve better.

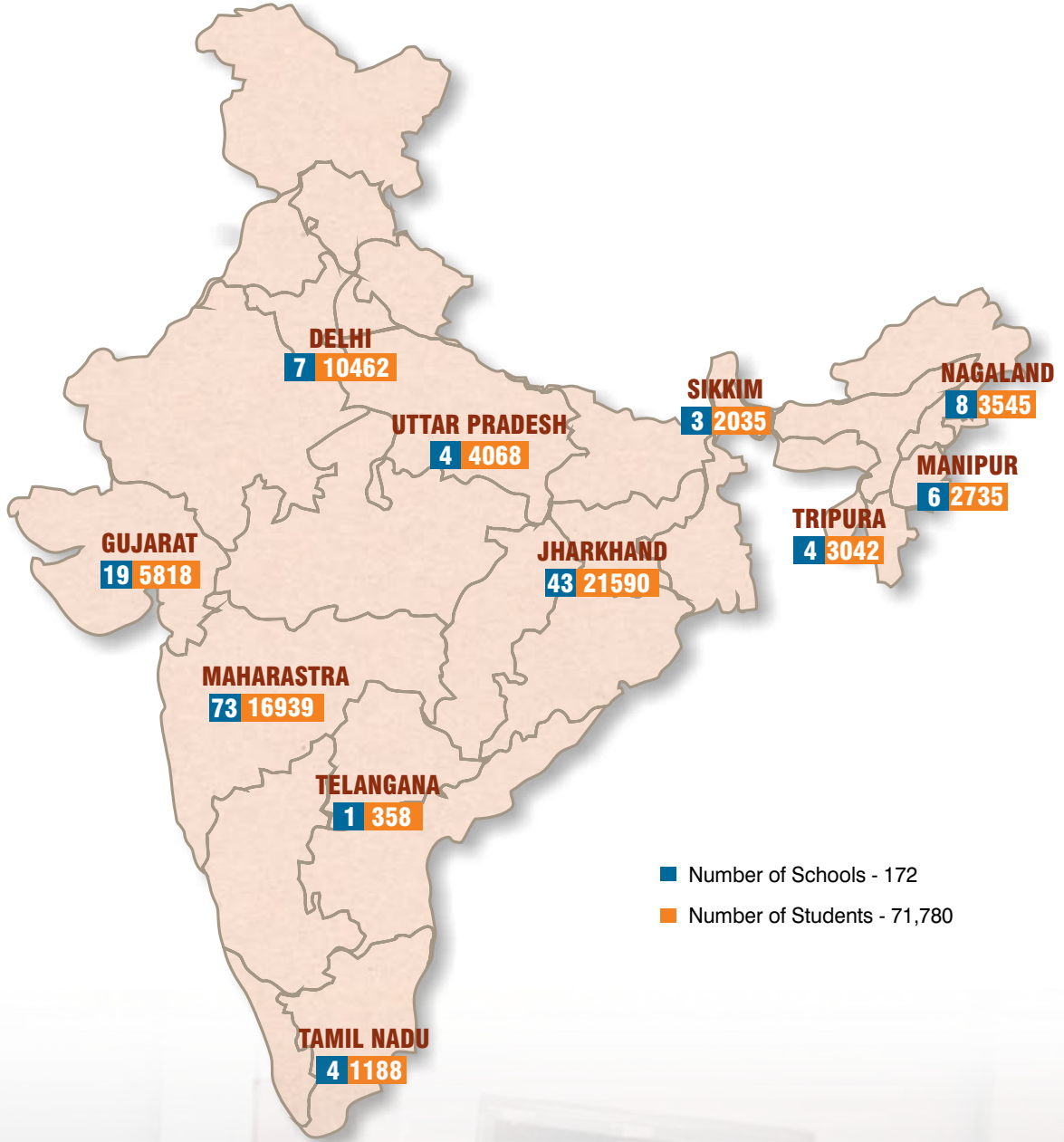
Greetings!!

- The Giftmilk Programme was launched on 26th February 2016

Report on the Audit of the Financial Statements

Opinion

We have audited the accompanying financial statements of **NDDB FOUNDATION FOR NUTRITION ("the Trust")** which comprise the Balance Sheet as at March 31, 2021, and the Income and Expenditure Account for the year then ended and a summary of significant accounting policies and other explanatory information.

1 Information about NDDB FOUNDATION FOR NUTRITION

NDDB FOUNDATION FOR NUTRITION is registered as Public Trust under The Bombay Public Trust Act, 1950 and also as a Society under The Societies Registration Act, 1860 with the main objective of providing nutrition support to children and needy persons *interalia* through milk/milk products and thereby contribute to the eradication of malnutrition.


